## **School Closures**

We cancel or delay classes due to snow or ice whenever the public schools do. Our automated phone system will call you when we have an inclement weather closure or delay. You can also listen to your local radio stations and watch local news on television to find out what decision the public schools in your area have made about delays or closures.

If the public schools delay classes by one hour, then Head Start classes will be delayed for one hour. If classes are delayed, they will still end at the same time as usual. If the public schools delay classes by two hours, then Head Start morning classes will be cancelled, but afternoon classes will be held on time. If the public schools are closed, all Head Start classes are cancelled.

#### The Tobacco Policy at Head Start

#### Family Changes After Enrollment

Please contact your child's teacher or your Family Educator if your address or phone number changes. It is very important that we have your current information in case of an emergency involving your child.



At enrollment each family filled out emergency contacts on the Persons Authorized to Receive Child form. This form authorizes certain people the family has chosen to be called in an emergency, pick your child up from school and receive your child from the bus. If your emergency contacts change contact your Family Educator or your child's Teacher immediately to fill out a new form. We will not allow your child to go home with someone that is not on the list.

#### **Confidentiality**

Information that is gathered about your child and family is kept confidential. At the end of the school year, records are locked in the Central Office. Records will only be sent to another school or agency with written permission from parents or legal guardians. Head Start staff and volunteers are responsible to maintain the confidentiality of all information about children and families. Here at Head Start, we are committed to the health of children and families in the program, as well as our staff. Our policy also reflects Oregon laws and Head Start requirements. Please read the following to know how the Head Start Tobacco Policy may affect you and your family.

Head Start staff, families, and visitors will **not** be allowed to use or have any tobacco products:

- On Head Start property
- At Head Start bus stops
- At Head Start functions such as field trips and parent meetings,
- Within the sight of Head Start children at school, and
- Please do not smoke during home visits or parent conferences that may occur at your homes.
- While at Head Start classroom functions and property, Head Start Staff, families, children and visitors may not wear clothing that smells strongly of smoke or advertises tobacco products.

Please contact your child's **Teacher** if you have any questions about the Tobacco Policy, the effects of smoking and second hand smoke, or how to quit smoking.



#### **Developmental Screenings**

During enrollment appointments, Head Start staff assist parents in completing the <u>Ages & Stages Questionnaire: So-</u> <u>cial-Emotional</u>. During a home visit with teachers before school starts, parents will complete the <u>Ages & Stages</u> <u>Questionnaire</u>, which measures a child's abilities in communication, physical development, and cognitive problemsolving.

Teachers and parents work together to use the information to plan a quality educational experience for each child. Parents are encouraged to discuss any concerns about their child's development with their Teacher.

#### **Disability Services**

Inclusive Classrooms: Head Start provides a range of services to children with identified disabilities. Parents, Head Start staff, and WESD (Willamette Education Service District) specialists work together to give your child the best learning experience possible. Head Start teachers include IFSP (Individual Family Service Plan) goals in every weekly lesson plan and WESD specialists come to our classrooms to provide Special Education services to children with IFSPs. Specialists will consult with teachers and may work with your child one-on-one or in small groups.

#### Referrals for Special Services

If teachers or parents see limited progress or developmental concerns in their child, Head Start staff can assist parents in preparing a referral for a free evaluation. We work in partnership with the WESD throughout the evaluation process. Head Start staff may also attend the evaluation and meetings to provide information about the child at school and to assist the parents to understand the process.

For help with referrals to the WESD or with questions about

Special Education services, you can talk with your child's teacher or contact Disability Services at the Central Office.



#### <u>Curriculum</u>

Teachers will observe each child to learn about their interests, abilities and how they learn. The focus is on creating a social, emotional and intellectual climate that lets children build relationships that support their exploration.

**Social and Emotional:** Teachers will respond to children's needs. Children will begin to hear the words that describe feelings; happy, sad, etc. Teachers will help children to begin friendships, solve problems, and try new things.

**Cognitive:** Children become confident learners by trying out their own ideas and experiencing success. Your child's interests will help us decide what activities will be available, to help them become motivated learners.

**Literacy:** Stories and books will be available to your child. Reading to a young child, (even pre-natal) encourages them to enjoy quiet time. By reading and talking about the pictures children begin to grow vocabulary and understand words and that putting words together has meaning. This will help your child to develop a love of reading for later in life.

**Language:** By listening to talking and singing, children begin to develop skills in listening and using words. Children will learn in their primary language, although English will be spoken in all classrooms.

**Physical Health and Development:** Children grow in their ability to control their muscles through activities like scooting, rolling, crawling, walking, kicking, throwing and running. Children learn about taking care of their bodies by blowing their noses, washing their hands, and using the restroom.

#### Why Does My Child Play So Much At School?

Young children achieve most of their learning through play. The classroom environment is divided into areas that offer specific types of learning through free choice play, including blocks, dramatic play, library, writing, sand and water, and toys/games. At any time in the classroom, you may notice teachers and children singing, dancing, or sitting quietly reading a book. The outdoor environment offers necessary and unique experiences that expand children's large muscle development and coordination (gross motor). Children will have opportunities for outside play every day, although weather will be taken into consideration. When circumstances exist that do not permit outside play, alternate indoor gross motor activities will be provided.

#### What Should My Child Wear to School?

Children should wear comfortable play clothes that are allowed to get dirty. Children paint, use play dough, play with sand, water and mud, serve themselves food, and play outside while they are at school. For safety reasons, children should wear shoes with closed toes and backs, preferably tennis shoes. Because children have the opportunity to enjoy daily outside play in various weather conditions, it is important that they wear clothing that is appropriate for the weather. Children should wear a jacket and warmer clothing, including a hat and gloves or mittens during colder months. Please send an extra set of clothing, including shoes and socks, if possible, that can be kept at school for your child to use in case they need to change their clothes for any reason. Diapers and wipes are provided by the program.

#### My Child is Sick: Should I Send My Child to School?

•Fever over 100 degrees, Diarrhea or Vomiting: Keep child home for at least 24 hours after the symptoms have stopped.

- •Cold, Cough, Sore Throat: Keep child home if cold or cough is severe even without a fever. If fever or swollen glands are present, consult your doctor.
- •Stomach Ache: Consult your doctor if stomach ache is severe or lasts longer than 4 hours.

•Rash: A rash can be caused by many things. Keep child home if fever is present or child is feeling ill. You may be asked to have the rash diagnosed.

•Chicken Pox: Keep child home until after crusts have formed (not sooner than 7 days after onset).

•Scarlet Fever: Keep child home until after clinical recovery (7 days minimum).

Your child may have a health condition not listed above that will require your child to stay home or that you pick up your child from school and take them home. Community Action Head Start wants your child to be at school every day, but when children are sick, the best place for them to be is at home recovering. Community Action Head Start reserves the right to require a doctor's note that clears your child for readmission into the classroom. In case of emergency, staff will contact emergency responders and parents as soon as possible. Staff will remain with the child or children until the parent or appropriate authorized person is able to be with the child. If your child has a serious health condition, please let staff know so that we can work together to keep your child well.

#### SCHOOL BUS RULES

Riding the Early Head Start Bus may be your child's very first time on a school bus. This can be a scary experience for children. Parents are always welcome to accompany their child on the bus to school to help them adjust. Items from home that may bring the child comfort, such as a blanket or a soft toy can be sent on the bus with the child. Head Start provides all required car seats for children under the direction of a certified car seat technician.



Please support us by following these transportation requirements:

- The bus may arrive a little bit early or slightly later than the scheduled time, so be ready 5 minutes before. If the bus will be later, expect a phone call from the site staff.
- Children must be seated in age and weight appropriate car seats as directed by the bus driver.
- No pets are allowed on the bus.
- No food is allowed on the bus, including candy and gum. This applies to all passengers.
- Do not bring hard toys or items on the bus for safety reasons. Jackets, hats, and other items should remain on the child or in the seat beside them.
- All adult passengers must wear seatbelts.
- When the bus stops at railroad crossings, all passengers must remain quiet as possible, until the bus crosses the tracks.
- Families, please no smoking within 10 feet of the bus. Second hand smoke is unhealthy for children.

#### **Daily Attendance**


Being at school on a regular basis is very important to your child's learning. You should send your child to school every day unless they are ill. If your child is sick or unable to attend class, please call the site before school or their bus pick up time to report the reason for the absence and when your child will return. Avoid unexcused absences by making sure not to oversleep, miss the bus, or planning appointments, visits or activities during class time. Parents may bring their child to school no more than five minutes before class time.

Planned extended absences must be discussed with your child's Teacher in advance.

#### Parent & Child Activities

Throughout the year, we will offer opportunities for family fun events in the community and at your sites. These are opportunities for parents to better connect with their children and be

better connected with the community. Parents are always welcome to speak with your Teacher or Family Educator with any ideas you may have.



### <u>Holidays</u>

Community Action Head Start will encourage children to learn about holidays in developmentally appropriate, fun ways. We will reflect the culture of our community in holiday practices while respecting culture and beliefs of individual families in the program. Family participation will be encouraged in planning and implementing holiday activities.

#### <u>Health</u>

A child's health will determine their ability to develop and to learn. According to federal requirements, all children at Head Start must be up-to-date with their health care. Please ensure the necessary exams are completed within 45 days of enrollment. In addition, Head Start staff perform a weekly health check on each child at school.

# In order to be up-to-date with health requirements your child must have:

- Immunizations including DTP, Polio, MMR, HIB, Hepatitis B, Hepatitis A and Varicella up-to-date.
  - Regular physical exams as required by ESPDT at: 2 Weeks, 2 Months, 4 Months, 6 Months, 9 Months, 12 Months, 15 Months, 18 Months, 24 Months, 30 Months & 3 Years old.
  - \* A dental examination within 12 months of the child getting their first tooth and then once a year after that.
  - \* Blood Lead level test results



Please let us know if we can help you with any part of this process.

#### Medications, Sunscreens and Ointments

If your child needs medication at school you will be required to turn it in before your child can start attending class.

Community Action Early Head Start staff may administer a prescribed medication to your child when the parent or guardian is unable to administer medications at home or outside of school hours and only when it is authorized by the child's health care provider. Before any medication can be given to a child, a Medical Treatment Plan must be completed by the child's physician and signed by the parent. Early Head start provides non-prescription diaper cream and sunscreen for your child if needed, these items will only be applied to your child with parental consent. Parents will be notified daily if either of these items were applied to the child that day.

#### Family Services

Parents and families have the really important job of raising children. We support families in being well and encourage positive parent and child relationships. Families teach their children and learn with them. We want parents to be a strong part of their community and be advocates for their children, as well as leaders in our program and community.

Please participate at parent meetings or serve on Policy Council. Attend fun family events throughout the year in our community, or connect with others in one of our parenting classes. Volunteer in the classroom and on the bus, or help to build desks and playgrounds. Please talk with your Family Educator or Teacher about ideas you may have.

#### Parent Concern Resolution

Parents who have a concern or complaint regarding the Head Start Program or an employee of the program issues are encouraged to take the following steps:

- A. Parents discuss the matter with classroom staff to help clarify Head Start policies and procedures.
- B. If the matter cannot be resolved with the classroom staff, parents are to contact the Regional Team Resource Specialist.
- C. If the matter cannot be resolved with the Regional Team Resource Specialist, it will be brought to the Program Director for final resolution.

## HOME VISITS



Teachers will communicate with you throughout the year during home visits, notes and phone calls. This allows education staff and families the

opportunity to develop relationships and share information.

Home visits will be scheduled monthly and will last at least 1 1/2 hours. At the visit, the parents and teacher will discuss goals for your child and family and ways to meet them. These goals will be discussed and updated throughout the school year. Parent child activities are planned to enhance your child's development and ideas for activities that will help you as a parent to provide ongoing support.

Family Services will be a part of your home visits . The purpose of these home visits are to develop a partnership with you and to support your family goals by providing information and resources. These home visits are also an opportunity for parents to share about how our Head Start program is doing and if our program is meeting your needs.

#### Meals at Head Start

All children in Head Start will be served a minimum of two nutritious meals every school day. Children will be served a breakfast and lunch while at school. Healthy snack foods are available for those children that need extra support foods during the day.

Meals are prepared in Head Start kitchens. Menus meet USDA guidelines and emphasize whole grains, milk, fresh fruits and vegetables, and are low in sugar, salt, and fat. Children are offered a variety of foods to broaden their food experience, while many cultural and ethnic preferences are honored. All meals are served "family style" where children learn to pass foods at the table, and serve themselves with supervision. Parents, you are welcome to join the classroom for meals. Parent support during this time is also welcome in helping to assist with preparation and clean-up, and assisting children at the tables.

If you would like to bring foods to share in the classroom, please check with your child's teacher to see what foods can be shared in the classroom.

If your child has special food requirements, please notify your teacher and contact the Health Specialist at 503-581-1152.



#### Mental Health

The Community Action Head Start Inclusion and Support Specialist will conduct classroom observations throughout the year. You can request an individual observation or additional screenings by speaking with your child's Teacher, Family Educator, or calling the Inclusion and Support Specialist at the Center Office.

We also have a play therapy clinic that families may request a referral for by contacting anyone on your child's teaching team. If you would like more information on our counseling clinic, please contact the Inclusion and Support team at the Center Office.



#### **Child Abuse Prevention**

Parents of children enrolled in Head Start are provided with a copy of the Child Abuse and Neglect Policy during their enrollment appointment. All staff at Head Start are mandatory reporters of child abuse. As mandatory reporters, staff are required by law to report child abuse or neglect to Department of Human Services Child Welfare or the police. Head Start staff are also required to report when a call is made to the home and the child states they are home alone or if there is no authorized adult present to receive the child after the school day has ended. Head Start keeps confidential all records pertaining to any report. Please inform staff if your child experiences any injuries or incidents at home.



#### HEAD LICE

For communicable disease prevention, children with live lice or nits will be sent home and may only return to the classroom when they are lice and nit free. Families must use an appropriate treatment to remove the lice and nits before the child returns to school. Children cannot return to school until a head check reveals that the child is free of both live lice and nits. Staff will support families in their efforts to treat head lice by providing consultation and referrals as needed.
