You may have noticed that we are bringing new child enrollment forms out to you on your visits. These forms now include the *Infant Feeding Benefit Notification And Acknowledgement* (what a mouthful!). For those of you who claimed infants in the past, you'll remember that infants had to have two forms filled out by the parent, one yellow and one white.


In the interest of paperwork reduction, these two forms have now been reduced to one. Current infant forms on file **do not** have to be redone. However, effective **October 1**st of this year, all **new** infants will need the new enrollment form. It makes it much easier for parents to sign just one form, and easier for you and the food program also! Parents do, of course, have to check the box as either accepting your formula or declining it. **As always, providers are required to write in the name of the formula they are supplying.** As a reminder, to comply with non-discrimination policy, child care providers are required to offer a formula. The parents can accept or decline the formula.

It might be best to just recycle any old enrollment forms you still have, because they will not be valid beginning in October. While you're at it, you might as well toss (recycle) old blank menu forms, as we now are using the menus that ask for meal times on at least one of the pages. Thanks!

Quick & Healthy Potato Salad

- \checkmark 1 ½ pounds red potatoes
- √ 1 cup plain nonfat yogurt
- √ 1/3 cup red onion, minced
- √ 1/3 cup celery, finely sliced
- \checkmark $\frac{1}{4}$ cup dill pickles, minced
- √ 1 Tbsp. juice from pickle jar
- / ½ Tbsp. yellow mustard
- ✓ 1/8 tsp. salt
- ✓ Ground pepper, to taste
- ½ cup fresh parsley,
 chopped

Place whole potatoes (do not poke) into a microwave-safe dish. Cover dish – if covering with plastic wrap, poke a small hole in the plastic. Microwave on high for 10 to 12 minutes. Use oven mitts to remove dish from microwave; carefully remove cover due to steam build-up. Let cool. Cut potatoes into bite-size pieces and place in a large bowl with remaining ingredients; stir well to mix. www.bhg.com





Provider Appeal Process

Nutrition First CACFP Seriously Deficient Determination

When Nutrition First makes a serious deficiency determination, providers will receive a letter outlining the reasons for the determination, the corrective actions required, and a timeframe in which to resolve all components of the determination of not more than 30 days from original date of notification. (Section C of the CACFP agreement between Nutrition First and the provider lists many, but not all, reasons for a serious deficiency determination.)

- The determination of serious deficiency is not subject to appeal.
- All valid claims will continue to be paid during the process, unless Nutrition First or another agency has determined there to be an imminent threat to the health and safety of children and others.
- ❖ If all corrective actions are deemed to be fully and permanently corrected, Nutrition First will inform the provider, in writing, that the serious deficiency determination has been rescinded.
- ❖ In the event that corrective actions are not implemented or are inadequate, Nutrition First will mail the provider a notice of proposed termination and inclusion of provider's name on the National Disqualified List. This notice is able to be appealed and will list procedures for appeal.
- If the provider voluntarily terminates, reimbursements will cease and the provider's name will be forwarded to the state agency (Oregon Department of Education) for placement on the National Disqualified List.
- If the provider appeals and prevails, no action will be taken because reimbursement payments have not been stopped.
- If the provider loses the appeal, the agreement will be terminated, payments stopped, and the provider's name placed on the National Disqualified List.

Note: A provider who is placed on the National Disqualified List will not be allowed to be a part of any USDA food program for a period of seven years, or longer if money is owed to the government.

One Pot Cheeseburger Casserole

- √ 1 Tbsp. olive oil
- √ 1 ½ pounds lean ground beef
- √ 1 cup onion, diced
- ✓ Salt and pepper to taste
- √ 1 28 oz. can whole peeled tomatoes, chopped
- ✓ 18 oz. can tomato sauce
- \checkmark $\frac{1}{2}$ cup low sodium broth

- ✓ 2 Tbsp. catsup
- √ 2 tsp. Dijon mustard
- √ ½ pound rotini pasta
- ✓ 1 cup water
- 2 cups shredded cheddar cheese
- \checkmark $\frac{1}{4}$ cup tomato, diced
- \checkmark $\frac{1}{4}$ cup green onions, sliced

Heat olive oil in a large pot over medium high heat. Add ground beef and onion and cook until beef has browned, about 3 to 5 minutes. Drain excess fat. Season with salt and pepper. Stir in



tomatoes, tomato sauce, broth, catsup, mustard, pasta, and water. Bring to a boil and simmer until pasta is cooked through, about 13 to 16 minutes. Remove from heat and top with cheese. Cover until cheese has melted, about two minutes. Top with the fresh tomato pieces and green onion. Makes 16 servings for 3-5 year olds, Vegetable, Meat, and Grain. www.mrfood.com

- ✓ 2 medium cucumbers
- ✓ 1 cup low-fat cottage cheese
- \checkmark 1 $\frac{1}{2}$ cup baby carrots or tomatoes (or other Veggie)

PROCESO DE LA APELACIÓN DEL PROVEEDOR

Nutrition First CACFP Determinación Seriamente Deficiente



- Cuando Nutrition First determina una deficiencia seria, el proveedor recibirá una carta informándole de la determinación de la deficiencia, la acción correctiva requerida, y el tiempo que tiene para resolver todos los componentes de la determinación de no más que 30 días de la fecha original de la notificación. (La sección C del acuerdo de CACFP entre Nutrition First y el proveedor lista muchas, pero no todas, las razones para que una determinación sea una seria deficiencia).
- La determinación de la deficiencia seria no es sujeta a apelación.
- * Todos los reclamos validos seguirán siendo pagados mientras en proceso, al solo que Nutrition First u otra agencia haya determinado que hubo una amenaza inmediata a la salud y la seguridad de los niños y otros.
- Si todas las acciones correctivas se juzgan corregidas completamente y permanentemente, Nutrition First informará al proveedor, por escrito, que la determinación de la deficiencia seria ha sido rescindida.
- En el evento que la acción correctiva no sea implementada o inadecuada, entonces Nutrition First enviará al proveedor, un aviso de la terminación propuesta y la inclusión del nombre del proveedor en la Lista Descalificante Nacional. Este aviso es apelable y enumerará los procesos para la apelación.
- Si el proveedor termina voluntariamente, los reembolsos cesarán y el nombre del proveedor entonces será enviado a la agencia del estado (Departamento de Educación de Oregon) para la colocación en la Lista Descalificante Nacional.
- Si el proveedor apela y gana, ninguna acción será tomada debido a que los pagos no habrán sido suspendidos. Pero, si la deficiencia seria no fue corregida permanentemente, propondremos terminar su acuerdo de nuevo.
- Si el proveedor pierde la apelación, el acuerdo será terminado, los pagos detenidos, y el nombre del proveedor colocado en la Lista Descalificante Nacional. Su nombre quedara en la Lista Nacional por 7 años (o más tiempo si no pago su deuda).

<u>ПРОЦЕСС АПЕЛЛЯЦИИ ДЛЯ ВОСПИТАТЕЛЯ</u> CACFP Nutrition First Определение Серьезного Недостатка.

- ❖ Если Nutrition First находит серьезный недостаток в работе воспитателя, воспитатель получает письмо, отмечающее причины замечаний и действия, требующиеся для их исправления. Срок исправления недостатков не более 30 дней от даты письма. (Секция С в САСFР Соглашения между Nutrition First и Воспитателем перечисляет многие, но не все, причины определения серьезного недостатка.)
- Определение серьезного недостатка не подлежит апелляции.
- ❖ Все действительные (подтверждённые) питания будут продолжать оплачиваться во время процесса, если только Nutrition First или другое агентство не определит немедленную угрозу здоровью и безопасности детей и взрослых.
- Если все требования по исправлению недостатков будут полностью выполнены, Nutrition First сообщит воспитателю письменно об аннулировании «Определения Серьезного Недостатка».
- В случае если исправительные действия не приняты во внимание либо не достаточны, Nutrition First сообщит воспитателю о Предложении расторжения соглашения и введении имени воспитателя в Государственный Список Дисквалификации. Это сообщение может быть обжаловано, и будет включать необходимые требования для апелляции.
- Если воспитатель добровольно прекращает работу детского сада, компенсации будут прекращены и имя воспитателя будет направлено в Штатное Агентство (ODE) для включения в Государственный Список Дисквалификации.
- ❖ Если воспитатель подал жалобу и был оправдан, никаких действий не будет предпринято, так как выплата компенсаций не прекращалась.
- ❖ Если воспитатель не был оправдан, соглашение будет прекращено, выплаты остановлены, и имя воспитателя будет включено в Государственный Список Дисквалификации.
