OUR COMPREHENSIVE APPROACH INCLUDES EMERGENCY SHELTER, RESOURCE NAVIGATION, HOUSING PLACEMENTS, AND ESSENTIAL SUPPORT SERVICES AIMED AT INDIVIDUALS FACING HOMLESSNESS AND HOUSING INSTABILITY IN MARION AND POLK COUNTIES.

DURING THIS PERIOD, WE SERVED A TOTAL OF 7,105 UNDUPLICATED INDIVIDUALS IN RENTAL ASSISTANCE PROGRAMS.

OUR ENERGY AND WEATHERIZATION SERVICES PROGRAMS INCLUDE LIHEAP (LOW-INCOME HOME ENERGY ASSISTANCE PROGRAM), OEAP (OREGON ENERGY

A TOTAL OF 890 CHILDREN WERE ENROLLED IN HEAD START AND OTHER CHILDCARE PROGRAMS.

OUR GOAL IS TO EMPOWER FAMILIES BY FOSTERING LIFELONG LOVE OF LEARNING WHILE ADDRESSING THEIR SOCIAL, MEDICAL, AND MENTAL HEALTH NEEDS. WITH 15 PROGRAM SITES, WE ARE COMMITTED TO OFFERING A RICH LEARNING ENVIRONMENT THAT IS BOTH EDUCATIONAL AND SUPPORTIVE, CREATING A WELCOMING SPACE FOR PARENTS. THROUGH A COMPREHENSIVE RANGE OF SERVICES, HEAD START PROMOTES THE HEALTH, WELL-BEING, AND OVERALL DEVELOPMENT OF BOTH CHILDREN AND FAMILIES.
